Preliminary provisions

On this page you will find the privacy statement of Harrie Leenders Haardkachels B.V. to (hereinafter: Leenders). You are advised to read this privacy statement carefully. Leenders has its registered office at Industrieweg 25, 5688 DP, Oirschot and is registered in the trade register of the Chamber of Commerce under number 17045218, and bears the name Harrie Leenders Haardkachels B.V. and Leenders. Leenders can be reached by e-mail at info@leenders.nl.

This privacy statement explains how Leenders handles the processing of personal data. For example, it is indicated which (categories of) personal data are collected and for what purpose the personal data is used. Leenders also indicates the legal basis on which the processing of the personal data is based.

The processing of personal data by Leenders falls within the statutory exemption regulations. For that reason, the processing has not been reported to the Dutch Data Protection Authority.

Leenders reserves the right to amend this privacy statement. The current privacy statement was last updated on 21-06-2018.

Types, purposes, legal bases and term of processing personal data

In the first place, personal data is processed if you conclude an agreement with Leenders. The personal data is used to contact customers. The form indicates which information must be filled in. This is all data relating to an identified or identifiable natural person. This concerns: e-mail addresses, names, telephone numbers, personal photos and IP addresses. It may also be a list of orders or websites visited. Your e-mail address will also be requested via the form. The e-mail address is necessary for contacting us, but is also used to inform you in the future about products or services that may be of interest to you.

The personal data is stored for a period of five (5) years.

Legal basis

The processing of your data is based on the following legal basis: the consent of the person/visitor is necessary for the processing of the personal data. This permission is important for contacting customers. Personal data that is physically collected

Leenders also collects personal data that is physically obtained from you during a meeting via an (introductory) conversation or signing the agreement. This concerns the same data as mentioned under the above paragraph. The collection of this personal data is therefore based on the same legal basis. By providing this information you also agree to this privacy statement.

Cookies

Leenders uses cookies on its website. What are cookies? A cookie is a piece of data that is placed on your computer by a website. Every time you visit the Leenders website, it collects basic technical information, such as which website brought you to this website. This privacy statement applies to cookies and similar technology. This website may use cookies to provide visitors with tailored information, to collect information, and to track the visitor while visiting the website. This helps Leenders to provide you with a good user experience.

Reference to other websites

This privacy statement only applies to this website and to the data collected as a result of an (introductory) conversation as a result of the visit to the website. This website may contain links to other websites that are not managed and/or owned by Leenders. If you ended up on another website by clicking on this link, the privacy statement of that website applies. Leenders is in no way liable or responsible for this website or for the privacy statement on this website. Transfer to processors and third parties

Personal data is processed by companies engaged by Leenders for the execution of the agreement. The law calls these companies "processors". You can think of the company that provides the hosting of the website of Leenders, or for example a printing company. Your personal data will also be shared with third parties if Leenders is obliged to pass on your personal data to competent authorities on the basis of a legal obligation.

Leenders has taken appropriate technical and organizational measures and to protect your personal data against loss or unlawful processing. The website has an SSL certificate, which means that the data is sent over a secure connection.
